Regardless of the reason, it was enough. I am sure the trial judge would have acted as he did had it been brought to his attention during trial. For the foregoing reasons I would reverse the judgment and remand the case for a new trial. NOTES [1] The appellant is also known as Carl Davis. [2] Pursuant to Arkansas Code Annotated § 16-89-309(b)(1), when a defendant is convicted of a capital felony and sentenced to life imprisonment, the defendant shall be given credit for time spent in custody under the sentence. This statute is mandatory in nature. See Heath v. State, 286 Ark. 303, 691 S.W.2d 554 (1985).
